Besides, it has more than 50 sets of advanced equipment, such as ICP, GCMS, ICS, TGA, DSC, FTIR, XRF, and thermal deformation Vicat Softening Temperature Tester, making it able to perform the tests of poisonous and harmful components, specified in standard directives such as RohS, Reach, and California Proposition 65, as well as the testing

and assessment of the overall performances of plastics.
